### St Mary Finance Council Minutes

#### II. Old Business

- a) <u>Religious Ed for 2023-24</u>- Maggan reported on numbers for St Mary (approx. 95 kids), rooms needed (9). She advised of 28-30 Confirmation and 5 or 6 for First Communion in 2023-24 year. These are estimates until registration happens in August. Maggan reported in the process of finding teachers but have some who committed already. Given numbers to some classes, she will need helpers for the teachers. Possible suggestions: use tables not desks for older kids, approx. 50 desks in church basement, use QofP room if Fr Kuhn agrees, TV's can be moved from Duman house to School. Dean advised Maggan that the school building has the Religious Ed is the priority and Maggan agreed to be open to ideas if other activities happen in the school. Possible rummage sale of remaining school items-tabled until next meeting.
- b) <u>Maintenance Report</u>-David reported 1.) bid for East side front of Church landscaping from James Valley for \$11K-council denied and wished to repair cement in driveway of parking lot. 2.) Bid from Iron Wheel for Duman House sink install (\$250) council approved 3.) Bid from Iron Wheel (\$2,850) for 2 water spickets install on E and W side of Church for watering Church grounds, council denied 4.) David reported of cracked cement during roofing project, Dean advised not to pay roofing bill until time to address the cracked cement 5.) Grasshopper lawnmower has interest, but no sale yet, council advised David to reduce price to \$5,500 or less if needed.
- c) <u>Set Ablaze Update</u>-Temporary Mass times put out, council had no questions. Discussed move in dates etc...
- d) <u>School Report</u>- 1.) St Mary School Commemoration Committee update by Cathy-Committee is Dean/Joann Koch; Jack/Vivian Sabers; Steve/Cathy Eichacker, Kurt/Kathy Stiefvater, and new member is Luann McKillop. To commemorate 134yrs of St Mary School on Saturday, Aug 12<sup>th</sup> on Church parking lot. Tentative to Fr Kuhn approval, schedule is open school, Mass in Church, Social, catered meal, choir to sing, Steve E. to be MC for event; they are working to get a program together and a one-day liquor license. 2.) Angie Horstman-FAST asked Council to reconsider Fr Jones request to keep FAST \$3K in the FAST parish checking account rather than moving to St Mary Ringneck Classic account due to having the Scholarships given from the Parish in the name of FAST and St Mary school. Cathy motioned, Dan 2<sup>nd</sup>, council approved to accept Angie's proposal to do with FAST funds what FAST asked from their May minutes (to move \$3,000 from FAST checking to St Mary Ringneck to secure scholarship funds for next 6 years) Angie advised council of possible dissolving of group as of June 30<sup>th</sup> per by-laws for changing officers and no school to operate under. Advised remaining approx. \$17K FAST funds to be spent in this manner: \$5K help with Commemoration; \$700 help with Peggy Freidel Benefit; 6K to 6.5K for Teacher Appreciation (8 teachers), and approx. \$5K for a memorial.
- e) <u>Roof repair, Steeple, Hall water damage claim</u>- Roof repair nearly complete; Steeple-Adjuster put through bid from Hofer Roofing to Insurance Co; Bid for Hall water damage was received by Adjuster/Insurance Co are reaching out to Salem Lumber for clarification of bid.
- f) 2023-24 Budget Dean advised it is at Diocese for finishing.

#### III. New business

- a) <u>May Financials</u>-questions arose about Gen to Gen account #128, Cathy requested printout of #9034- Gen to Gen dedicated account, Barb to obtain. Barb advised SCRIP numbers are including inventory on hand. Barb to get printout from Carol M. for any gift cards given as gifts to teachers, etc.
- b) <u>Barb Misc. items</u> -Vitalant Rep called again and council agreed to not have the blood drive take place in our school building until knowledge of school use is known –tabled for new priest input; Dean reviewed Catholic Mutual Insurance Renewal 7.1.23, Barb to file; Barb advised council of First Dakota Money Market account with inactivity notice, Council discussed and agreed for Tim to go to bank and move money to a 6-month CD.
